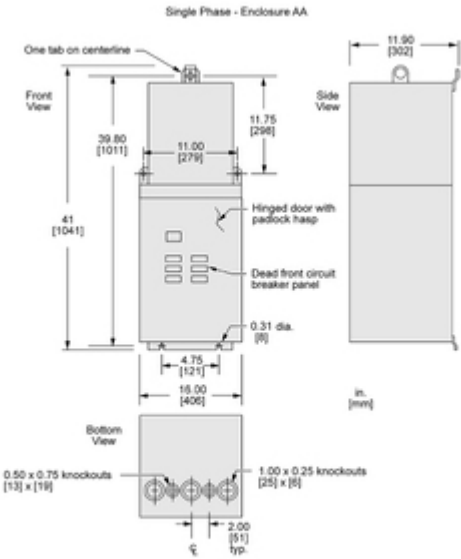

Wiring diagram

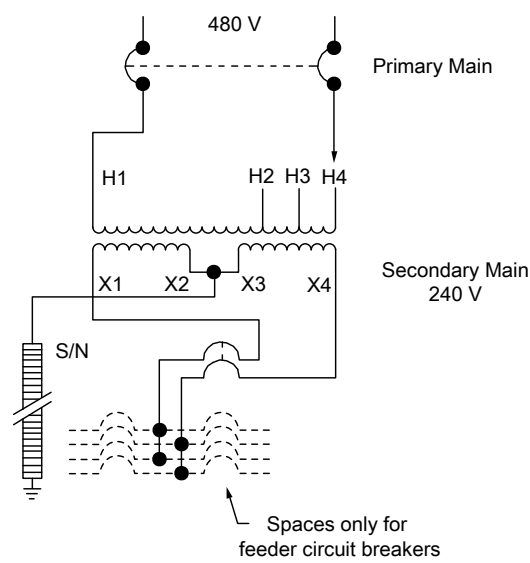
